**Minutes.**

Minutes of the meetings held on Tuesday 7<sup>th</sup> May 2019 and Monday 13<sup>th</sup> May 2019. Minutes previously distributed, discussed, approved & signed by the Chairman.

**Matters Arising.**

**Clerks Vacancy.** This was discussed further. The position has been advertised in the Sheriff Hutton News, on Lillings Ambo Parish Council Website and on the Village Noticeboard. No voluntary offers received. The Clerk for Sheriff Hutton has enquired but this would be for a paid position. The Clerk for Foston & Thornton le Clay has been contacted by the Chairman. No reply yet. The Parish Councillors will continue to encourage a local person to take the position on a voluntary basis. This will be discussed again at a future meeting. A special meeting will be called if needed.

**Planning.**

**19/00434/HOUSE. Mr & Mrs S. Loynes.** Erection of single storey side extension. This application had previously been discussed by the Council who had no objections. Approved by Ryedale District Council 5-6-2019

**19/00471/HOUSE. Mr B.Rycroft.** Erection of first floor extension above existing flat roofed attached garage to include a monopitch roof to front of garage. Previously discussed by the Council who had no objections.

Approved by Ryedale District Council 7-6-2019

**19/00597/HOUSE. Mrs A. Hodgson.** Erection of two storey side and rear extension with integrated garage and erection of porch to front elevation. Previously discussed by the Council who had no objections. Approved by Ryedale District Council 15-7-2019.

**Any Other Business.**

- a) The Clerk will contact Highways re the broken fence on the small bridge on Back Lane.
- b) Concerns were raised and discussed re the speed of traffic on York Road between the Cricket ground and the properties on Bracken Hill. This will be raised with County Councillor Goodrick.
- c) A Drone had been seen landing in the rear garden of a house in the village. It then took off towards Flaxton and was seen flying low over East Lilling. Any further sightings will be reported to the police.
- d) The Chairman has received a copy of a solicitor's letter from Mrs Hodgson re their concerns with 'Inturf' Lorry's using the narrow lane and bridge over the River Foss off Low Lane. The bridge and lane are part of 'The Centenary Way'. As this is a private matter the letter is for information only.

**County Councillor Caroline Goodrick.**

County Councillor Caroline Goodrick arrived and was welcomed to the meeting. She was introduced to the 2 new Parish Councillors. A briefing on her work at North Yorkshire County Council and Ryedale District Council was given. This includes sitting on many committees including Health & Adult Care, Children & Young People Services, Environmental Services, The Appeals Committee for Home to School Transport, Chairman of Ryedale District Councils Planning Committee and numerous others. It was explained to the Council that NYCC are now taking a more commercial approach eg Allerton Park Waste Incinerator which handles 95% of North Yorkshires waste. Projects like this generate income to subsidise other services.

The Parish Council expressed concerns regarding the state of the areas roads and the speed and type of vehicles using them. This was noted.

**Chairman's Report.**

a) The River Foss / Environment Agency Scheme. The scheme was explained to County Councillor Goodrick who had no knowledge of this scheme. She will review the scheme and enquire why she and Ryedale District Council had not been informed. Kevin Hollinrake MP for Thirsk and Malton will also be contacted on this scheme. The Parish Council should encourage affected individuals to write to express their concerns to K, Stevens at NYCC and Gary Housden- Head of Ryedale Planning. The Parish Council will be kept informed of information received.

The Environment Agency are to be invited to the November Parish Council Meeting. County Councillor Goodrick and District Councillor Eric Hope will also be invited to the next meeting.

b) The Old Village Post-box. The old Village Post-box in the wall of Postbox House has been removed and is being refurbished.

County Councillor Caroline Goodrick was thanked for attending the meeting. An invitation to the next meeting and details of the Environment Agency attendance at the November meeting will be forwarded to her.

District Councillor Eric Hope will be invited to the November meeting.
