Ordinary Vacancy Co-option.

After discussions on the 2 Co-option Candidates on Tuesday 7th May, Mr J.Armitage had been invited to attend this public meeting to be Co-opted onto the Parish Council. Mr J.Armitage confirmed his interest in becoming a Lillings Ambo Parish Councillor. All Councillors agreed that Mr J. Armitage be Co-opted. Proposed - Councillor R.G.Barker Seconded - Councillor D.McBurney. Mr J.Armitage signed the 'Declaration of Acceptance of Office as a Parish Councillor' form and agreed to accept the 'Councils Code of Conduct'. - 3) The members considered the findings of the effectiveness of the system of Internal Control & confirmed its effectiveness. All Councillors Agreed.

- 4) Members reviewed the Annual Governance Statement & confirmed 'Yes' to all points. Each Councillor had a copy of the statement.
